Working at AKA Case Management Limited to provide a collaborative service that assesses, plans, implements, monitors and evaluates support options and services that meet the unique needs of an individual who has suffered traumatic injury.

Examples of some of my current case load include:

- Working with a male who has a severe brain injury, facial trauma and visual difficulties. I was instrumental in the research and instruction of a multi-disciplinary team of therapists and support. Through collaborative working we are supporting the client to work towards his identified goal to engage in a period of neuro-rehabilitation within a specialist centre. In addition, areas of support with this gentleman have seen us work through times of significant crisis, re-homing, anger management, criminal proceedings, application of benefits and associated appeals. Mid-long term goals include, gradual reintegration into supported living and vocational opportunities.
- Working with a 53 year old male who sustained a severe brain injury and orthopaedic injuries. Coordinating a team of specialist therapists i.e. neurophysiotherapy, neuro-psychology and occupational therapy to monitor and optimise his levels of activity and goal to attend an assessment with Great Britain Para-Cycling. Additional areas of support to this gentleman have been around demystifying the litigation process, providing support and representation at a benefits tribunal (following several previous unsuccessful appeals he received a successful backdated award).
- Working with a 24 year old female who as a result of a brain injury lacks insight and awareness. This young lady is high functioning on many levels but exhibits more subtle cognitive difficulties. By establishing a therapeutic relationship with the client built on trust, we explored her acceptance of therapies and support whilst increasing her sense of having control over her life. Therapies and support are now established and the client has achieved successful outcomes in vocational activities and has returned to driving.
- Working with a 23 year old male with Cerebral Palsy. Maintaining an overview
 of the therapy programme enabled me to recognise that a change of
 therapist would be in the client's best interests to ensure that therapy and other
 interventions are appropriately meeting his changing needs. Offering the

support, reassurance and allowing the client to express any anxieties he has now fully accepted and engaged with his new therapist and making great gains. My role requires ongoing coordination and monitoring of the therapy team and commencement of an independent living trial remains a short term goal.
