Working at AKA Case Management Limited to provide a collaborative service that assesses, plans, implements, monitors and evaluates support options and services that meet the unique needs of an individual who has suffered traumatic injury.

Examples of some of my current case load include:

- Management of a settled litigation case, working with a 60-year-old female who has an acquired brain injury. Building a strong professional relationship working collaboratively with the client, therapy, support, and care teams. Liaison with professionals, including local authority and finance deputy in relation to rehab goals, concerns, and exploring funding options. Support with property identification, adaptions move with ongoing liaison with architect and builders. Identification of appropriate support following several hospital admittances/diagnoses. Organisation of relevant increases/decreases as and when necessary working collaboratively to ensure managed effectively.
- Working with a 57-year-old male who has an acquired brain injury, poor mobility, and lack of cognitive skills/awareness. Instrumental in the research process and instruction of a private Physiotherapist and supported/encouraged the client to achieve the therapy goals. Also identified the client's personal goals using motivational interviewing techniques, encouraging new interests and removal of client barriers associated to the brain injury or mobility. Co-ordinating GP and hospital appointments and supporting the client with any correspondence completion.
- Working with an 8-year-old boy who experienced a Hypoxic Ischemic Encephalopathy (HIE) after being born flat resulting in the client requiring support 24/7 for daily living and personal care. He has Cerebral Palsy - spastic and dyskinetic which affects all four limbs and has epilepsy. Working collaboratively with a multidisciplinary team and implementing care plans, support plans and risk assessment and completing CQC documentation home/safety and environmental checklists. Liaising with family regarding support package and equipment concerns requirement and carrying out observations. Assisted with the recruitment and implementation of a rehab support worker with paediatric nursing experience.

Working collaboratively with the professionals involved to identify goals and strategies following discharge from a rehab centre into the client's own home. Management of transition from care to independent living and promoting independent living skills. Instrumental in the management of behavioural changes/impact associated to discharge resulting in liaison with local authority support team and deputy highlighting concerns around risk. Implementation of risk assessments to manage/mitigate the risks identified to the client/support team that were associated to these behaviours and those involved.
